

# TERMS OF SERVICE AGREEMENT

## **ACCEPTANCE OF TERMS**

The following Terms of Service Agreement (the "TOS") is a legally binding agreement that shall govern the relationship with our users and others which may interact or interface with The Oyster Common LLC, also known as Oyster Common, located at 8 N Meadow Rd, Amherst, New Hampshire 03031 and our subsidiaries and affiliates, in association with the use of the Oyster Common website, which includes [www.oystercommon.com](http://www.oystercommon.com), (the "Site") and its Services, which shall be defined below.

## **DESCRIPTION OF WEBSITE SERVICES OFFERED**

The Site is an e-commerce website software as a service which has the following description:

The Oyster Common (OC) is a software-as-a-service (SAAS), which integratively processes sales and prints shellfish tags.

Any and all visitors to our site, despite whether they are registered or not, shall be deemed as "users" of the herein contained Services provided for the purpose of this TOS. Once an individual registers for our Services, through the process of creating an account, the user shall then be considered a "member."

The user and/or member acknowledges and agrees that the Services provided and made available through our website and applications, which may include some mobile applications and that those applications may be made available on various social media networking sites and numerous other platforms and downloadable programs, are the

sole property of The Oyster Common LLC. At its discretion, The Oyster Common LLC may offer additional website Services and/or products, or update, modify or revise any current content and Services, and this Agreement shall apply to any and all additional Services and/or products and any and all updated, modified or revised Services unless otherwise stipulated. The Oyster Common LLC does hereby reserve the right to cancel and cease offering any of the aforementioned Services and/or products. You, as the end user and/or member, acknowledge, accept and agree that The Oyster Common LLC shall not be held liable for any such updates, modifications, revisions, suspensions or discontinuance of any of our Services and/or products.
